About Trust Funding

As part of the OPEB Funding Agreement (between Stelco, the province and the trustees of Local 8782 Retiree Benefits Trust), Stelco has agreed to pay for the cost of benefits plus expenses through the Trust arrangement for at least the next 10 years. After that, the Trust will continue as long as Stelco is able to meet its annual funding commitments. It's our job as your trustees to see that the money in the Trust is spent appropriately – in a best effort to ensure that the Trust remains active for as long as members are making claims.

GOOD THINGS HAPPENING...

Here are some changes we've been able to make so far

Enhanced the Travel Medical Emergency coverage

Last year, coverage was expanded to help cover you when you travel. Our Out-of-Province/Country Travel Medical Emergency coverage through Royal and Sun Alliance (RSA) now features coverage for up to 90 days per trip, with a \$5 million lifetime maximum.

Introduced a Claims Appeal process

Our Claims Appeal process is now in place, in case you have a benefits claim denied that you don't agree with.
